Description:

A pharmacist in this role will be introduced to various outpatient clinics. The role of the ambulatory care pharmacist includes identifying patients scheduled for physician visits who may benefit from pharmacy input, collecting patient information from the electronic medical record, interviewing patients, counseling patients, and providing recommendations to physicians. During the rotation, residents will begin to develop their pharmacotherapeutic skills, broaden their knowledge base, and serve as a clinical resource for the physicians and nurses. Residents may also have the opportunity to precept pharmacy students.

Learning Experience Responsibilities:
